ARTICLES OF ORGANIZATION CARL S. CANNOVA, LLC

TATELANASSEE PHIE 20

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes the purpose of forming a limited liability company under the laws of the State of Florida does set forth the following:

ARTICLE I - Name

The name of the limited liability company is: Carl S. Cannova, LLC, hereinafter referred to as the "Limited Liability Company."

ARTICLE II - Address
