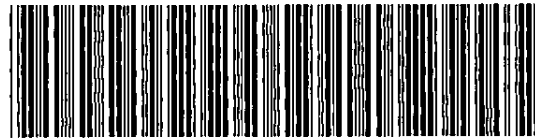

The undersigned hereby adopts these Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, and makes, acknowledges and files the following Articles of Organization.

**ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the Regulations.

**ARTICLE VIII - ADMISSION OF NEW MEMBERS**

**JOHN G. KEPOROS, AS TRUSTEE OF THE JOHN G. KEPOROS TRUST, DATED NOVEMBER 3, 2009**, shall be the initial Member, and except as set forth in the Regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


**ARTICLE XI - AMENDMENTS**

**ARTICLE XII - REGULATIONS**


