ARTICLE IV

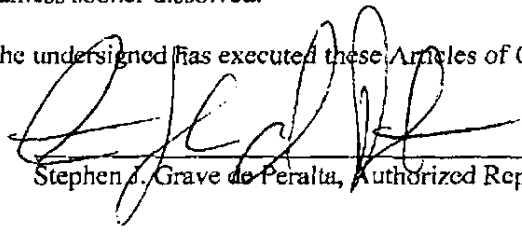
