The street and mailing address of the principal office of the Company is 10439 Alta Drive, Jacksonville, Florida 32226.

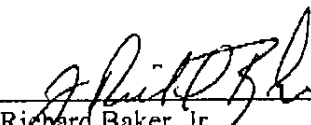

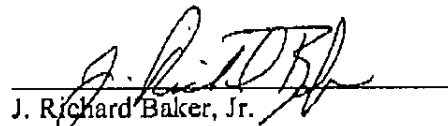
