The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **39 CB PROPERTIES, LLC**, a Florida limited liability company (the "Company").

ARTICLE II -- ADDRESS

ARTICLE V -- CAPITAL CONTRIBUTIONS


ARTICLE IX -- TERMINATION OF EXISTENCE
