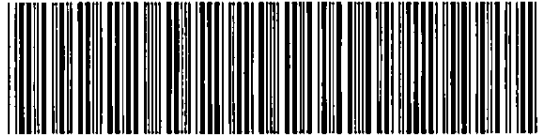

4. The Company no longer holds any assets and is not conducting any business; as such, the members of the Company desire to dissolve the Company.

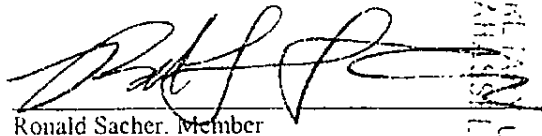
5. All debts, obligations and liabilities of the Company have been paid or discharged.
