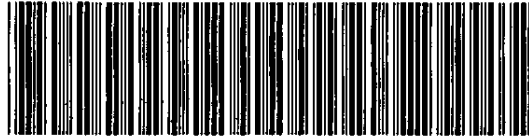

The effective date of the Dissolution shall be the date of filing.


ARTICLE IV - OCCURRENCE RESULTING IN DISSOLUTION
