**Article I
Name**

The name of the limited liability company ("Company") is The Fun Bus, LLC.

**Article II
Address**

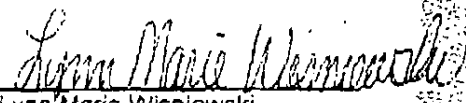
Article VII
Admission of New Members

Members of the Company have the right to admit new members. Article VIII
