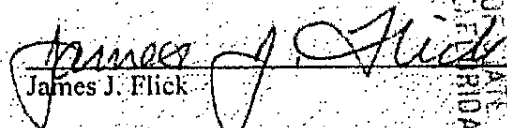

FIRST: The original Articles of Organization were filed on September 24, 2012, and assigned Document No. L15000064788.

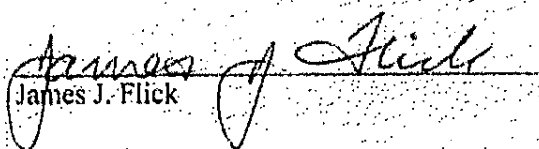
SECOND: Article I of the Articles of Organization is hereby amended to read as follows: The name of the Limited Liability Company is EXLNT HOTLZ LLC.
