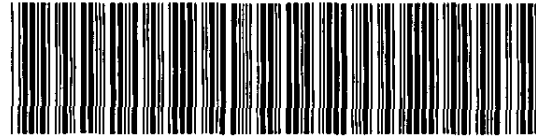

**ARTICLES OF ORGANIZATION**

**ARTICLE I – Name**
