The mailing address and street address of the principal office of the company is 8004 NW 154th Street, Suite 387, Miami Lakes, FL 33016.

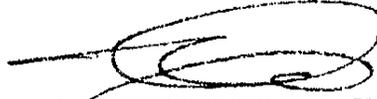
ARTICLE III -- DURATION

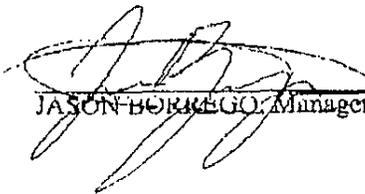
