FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF  
LANDSTAR PARK GROUP MANAGERS, L.L.C.

THIS FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF  
LANDSTAR PARK GROUP MANAGERS, L.L.C. is made effective as of May 9, 2015.  
("First Amendment"), by FCH PARTNERS II, LTD., a Florida limited partnership (the  
"Member").

RECITALS

(A) Landstar Park Group Managers, L.L.C. (the "Company") was formed as a Florida  
limited liability company on April 15, 2015, by the filing of Articles of Organization with the  
Florida Department of State;

(B) The Company was further made and established pursuant to an Operating  
Agreement of the Company dated as of April 15, 2015 ("Operating Agreement");

(C) The Company is presently constituted and governed pursuant to the Operating  
Agreement; and

(D) The purpose of this First Amendment is to provide for the removal of a Manager  
and admission of a substitute Manager in its stead.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable  
consideration, the parties hereto do hereby agree as follows:

1. Capitalized Terms. Capitalized terms not otherwise defined in this First  
Amendment shall have the meanings ascribed to such terms in the Operating Agreement.

2. Managers. As contemplated in Article VI, Sections 6.1 and 6.2 of the Operating  
Agreement, the current Managers of the Company are as set forth on the attached Exhibit A.

3. Effect of Amendment. Except as amended herein, the Operating Agreement shall  
remain in full force and effect.
