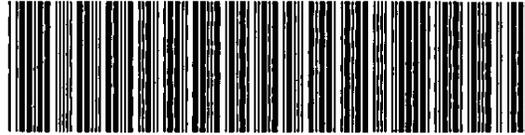

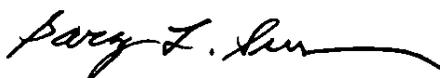

**ARTICLES OF ORGANIZATION
OF
DT & MT, LLC**

The undersigned, Dennis A. Thompson, hereby certifies that he is the authorized representative of the members for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, providing for the formation, rights, privileges, and immunities of limited liability companies for profit, and the following Articles of Organization are hereby adopted.

**ARTICLE I.

ARTICLE VI.
Restrictions of Membership;
Right to Admit Additional Members
