**ARTICLES OF ORGANIZATION  
OF  
ACR 2015 LLC**

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is ACR 2015 LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address of the Company is 3551 NW 116<sup>th</sup> Street, Miami, Florida 33167.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company designates 3551 NW 116<sup>th</sup> Street, Miami, Florida 33167 as the street address of the initial registered office of the Company and names Alfredo J. Reviati as the Company's initial registered agent at that address to accept service of process within this state.

**ARTICLE IV. DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement or pursuant to the Act, as amended from time to time.




