ARTICLES OF ORGANIZATION
OF
GMC ENCLAVE MANAGER, LLC

The undersigned organizers, who are members of GMC ENCLAVE MANAGER, LLC ("Company") under the Florida Revised Limited Liability Company Act, hereby adopt the following Articles of Organization.

ARTICLE I - NAME
