Marquis, LLC, hereby presents these Articles of Organization as the Articles of Organization of Michael B. Marquis, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

**ARTICLE VI - MANAGEMENT**

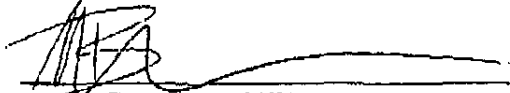
