**ARTICLES OF ORGANIZATION
OF

The undersigned, Shannon Lakela Moore, a natural person competent to contract and a member of BE MOORE MOBILE AUTO DETAILING AND PRESSURE WASHING, LLC, hereby presents these Articles of Organization as the Articles of Organization of BE MOORE MOBILE AUTO DETAILING AND PRESSURE WASHING, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is BE MOORE MOBILE AUTO DETAILING AND PRESSURE WASHING, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
