

**ARTICLES OF ORGANIZATION OF  
PATRICK FARNAN, LLC**

The undersigned, desiring to form a limited liability company under the provisions of Sections 605.0101 *et seq.*, Florida Revised Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is PATRICK FARNAN, LLC.

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 5819 Interbay Blvd., Tampa, FL 33611.

Article III. Registered Office and Agent. 

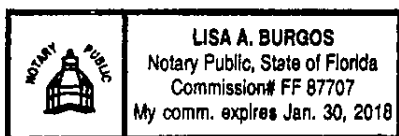


