**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF

1. The current name of the Company is TAVISTOCK DEVELOPMENT PROPERTY HOLDINGS, LLC.

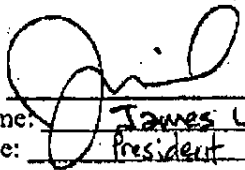
2. The date of filing of the original Articles of Organization of the Company was April 20, 2015, document number L15000069413.
