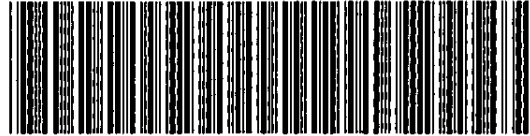

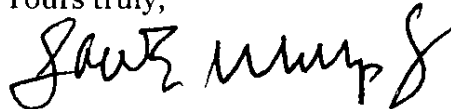

**ARTICLES OF ORGANIZATION FOR
GLORIA LANE, LLC**

The undersigned, for the purpose of forming a limited liability company under the provisions of Chapter 605, Florida Statutes (the Act), hereby sets forth the following.

ARTICLE I

NAME

The name of the limited liability company is GLORIA LANE, LLC (the Company).

ARTICLE II

ADDRESS

The mailing and street address of the principal office of the Company is c/o 11211 Prosperity Farms Road, Suite B201, Palm Beach Gardens, FL 33410

ARTICLE III

DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual until dissolution of the Company upon the first to occur of (a) the written consent of the member(s) or (b) the entry of a decree of judicial dissolution under the Act, or as required under the Act.

of the Company are created, incurred, or evidenced, which are necessary, appropriate or beneficial to carry out or further such decisions or actions.

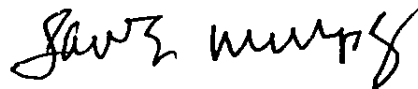
ARTICLE VI
