


5. The effective date of these Articles of Conversion and the attached Articles of Organization shall be date of filing with the Florida Department of State.



The undersigned, Shannon Howell, a natural person competent to contract and an authorized representative of Business Ideas, LLC, hereby presents these Articles of Organization as the Articles of Organization of Business Ideas, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

ARTICLE VI - MANAGEMENT


