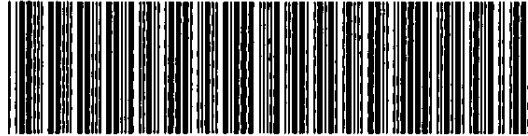

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Cakes by Jessi, LLC (the "Company"). The Company's principal address and mailing address is 4104 W. Sitka St., Tampa, Florida 33614. The Company's initial registered agent is Anthony M. Hornnik, Esq., whose address is 314 W. Wilder Ave., Tampa, Florida 33603. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

ARTICLE II

Duration of Existence

Management of the Company




