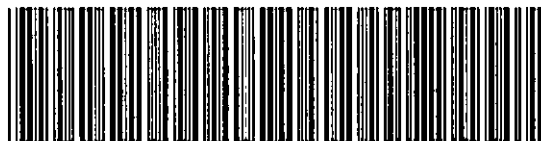


**STATEMENT OF RESIGNATION OF REGISTERED AGENT**

DME Group, LLC, subsequently filed its Articles of Dissolution on or about April 29, 2022, with a delayed effective date of June 1, 2022.


