ARTICLES OF ORGANIZATION OF HISTORIC CHARLESTON LLC

The undersigned, an authorized representative of a prospective member, desiring to form a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby adopts the following Articles of Organization:

The name of the limited liability company is Historic Charleston LLC (the "Company") ARTICLE II - ADDRESS The street and mailing address of the Company's principal office are: One Independent Drive, Suite 1200 Jacksonville, Florida 32202 ARTICLE III - PURPOSE

To the fullest extent not prohibited by law, the Company shall advance reasonable indemnification expenses (including attorneys' fees and costs) for actions taken in the capacity of such person as a manager, member or officer within twenty (20) days after receipt by the Company of (i) a written statement requesting such advance, (ii) evidence of the expenses
