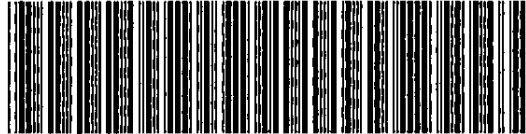

ARTICLES AND CERTIFICATE OF CONVERSION
OF ALL FLORIDA PAPER, INC. WITH AND INTO ALL FLORIDA PAPER, LLC

This Articles and Certificate of Conversion (the "Articles of Conversion") and the attached Articles of Organization are submitted to convert ALL FLORIDA PAPER, INC., a corporation organized under the laws of the State of Florida, into ALL FLORIDA PAPER, LLC, a limited liability company organized under the laws of the State of Florida, in accordance with Sections 607.1114 and 605.1045, Florida Statutes.

1. ALL FLORIDA PAPER, INC., a corporation organized, and immediately prior to the filing of this Articles of Conversion, existing under the laws of the State of Florida was formed on May 28, 1993, under Document Number P93000038439.
2. The name of the Florida limited liability company into which ALL FLORIDA PAPER, INC. will be converted is ALL FLORIDA PAPER, LLC. The Articles of Organization of ALL FLORIDA PAPER, LLC are attached to this Articles of Conversion.
3. The conversion of ALL FLORIDA PAPER, INC., a Florida corporation, into ALL FLORIDA PAPER, LLC, a Florida limited liability company, is in compliance with the Florida Business Corporation Act, Chapter 607, and in compliance with the Florida Limited Liability Company Act, Chapter 605.
4. The conversion of ALL FLORIDA PAPER, INC., a Florida corporation, into ALL FLORIDA PAPER, LLC and the Articles of Conversion were approved by all of the shareholders and directors of ALL FLORIDA PAPER, INC., in accordance with the provisions of Section 607.1112 of the Florida Business Corporation Act.
5. The address of the principal office of ALL FLORIDA PAPER, LLC is 9150 NW 105th Way, Medley, Florida 33178. In that this conversion complies with Section 368(a)(1)(F) of the Internal Revenue Code of 1986, as amended, the Federal employer identification number for ALL FLORIDA PAPER, LLC will be 65-0414657 which is the same Federal employer identification number of ALL FLORIDA PAPER, INC.
6. The Articles of Conversion shall be effective upon its filing with the Florida Department of State.
7. ALL FLORIDA PAPER, LLC shall pay any shareholder of ALL FLORIDA PAPER, INC. having appraisal rights in an amount as set forth in Section 607.1301 through 607.1333 of the Florida Business Corporation Act. However, no shareholder of ALL FLORIDA PAPER, INC. is exercising any appraisal and/or dissenter rights.
8. The Articles of Conversion have been approved by all of the members of ALL FLORIDA PAPER, LLC in accordance with Sections 605.1041 to 605.1046.
