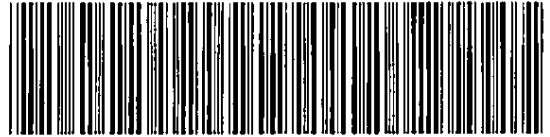

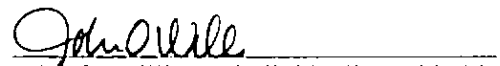

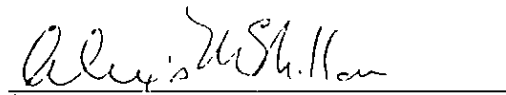
4. The written actions taken by the initial members on September 25, 2018, amending the Articles are also hereby adopted, ratified and approved by the new members designated herein.

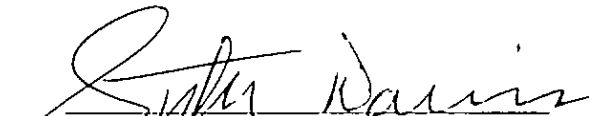
