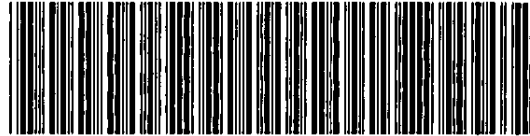



1. **Name.** The name of the limited liability company is CELEBRATION CLOSING ASSOCIATES, LLC.
