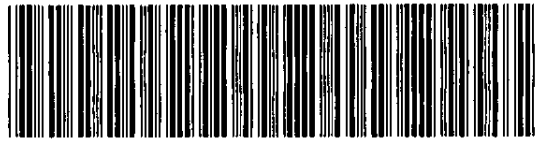

**FIRST AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION

The Articles of Organization of T.V. 
