TO
ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Statutes, **TWO LITTLE RHINOS, LLC**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

Name

ARTICLE II

Amendment
