MANAGEMENT

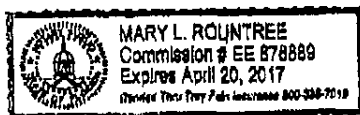



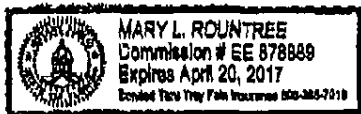
