The name of the Limited Liability Company shall be **Ubik Promotional, LLC**

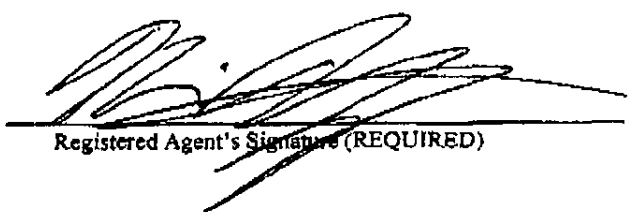
