ARTICLES OF ORGANIZATION OF 3315 N. LIBERTY, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be 3315 N. Liberty, LLC.

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is: One Independent Drive, Suite 3120, Jacksonville, Florida 32202.

ARTICLE III PURPOSE

The purpose for which the Company is being formed is to acquire, hold, lease, sell, develop, and otherwise deal with real property and to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV DURATION

ARTICLE VII REGISTERED AGENT AND OFFICE

ARTICLE VIII CONTINUATION OF BUSINESS

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.
