ARTICLES OF DISSOLUTION OF

- SECOND:** The Articles of Organization were filed on May 4, 2015 and assigned document number L15000078139.
- THIRD:** The date of the adoption of these Articles of Dissolution is 12 April 2019.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
