

Articles of Amendment to the Articles of Organization of JD 2015 LLC



The Articles of Organization for JD 2015 LLC, a Florida Limited Liability Company ("Company") were filed on May 4, 2015 and assigned Document Number L15000078494. These Articles of Amendment are submitted to amend the following:

1. ARTICLE III (Other Provisions, if any) of the Articles of Organization of the company is amended in its entirety wherein said Article shall now read as follows:

ARTICLE III (Other provisions, if any):

- A. The Company will be a manager-managed company.
- B. The Company's nature of business is: (i) the wholesale and retail sale of residential and commercial furniture, equipment and other interior or exterior building and building improvement products and accessories; (ii) the wholesale and retail provision of interior/exterior design and plan services for residential and commercial furniture, equipment and other interior or exterior building and building improvement products and accessories; and (iii) the right to transact and engage in any and all activity or business as permitted by any laws, whether such laws are state, federal or international.
- C. The Company shall exist perpetually.

The effective date of these Articles of Amendment will be the date of filing. Except as modified herein, all other provisions as set forth in the original Articles of Organization for the Company shall remain in full force and effect. The undersigned, as the manager of the Company, represents that the Company followed its requisite procedures to amend the original Article of Amendment and file these Articles of Amendment, and that the undersigned has the authority to execute and file these Articles of Amendment on behalf of the Company.
