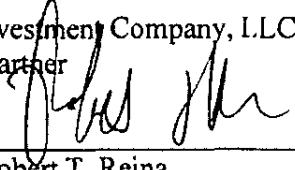
1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is Reina Real Estate V LP.

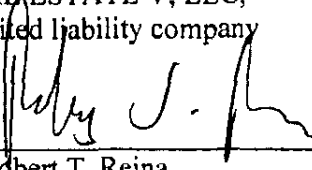

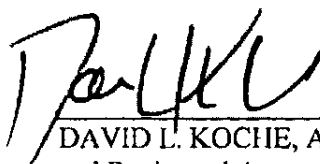
The Company is to be managed by one or more managers and is, therefore, a manager-managed company.
