- SECOND:** The Articles of Organization were filed on May 5, 2015, effective July 3, 2014 and assigned document number L15000079202.
- THIRD:** The date of the adoption of these Articles of Dissolution is 27 March 2020.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
