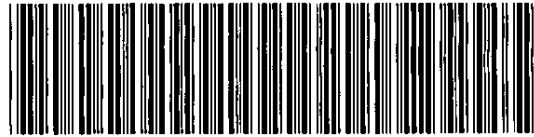


1. The date of filing of the Articles of Organization of **KAZU CONSULTING, LLC** was May 6, 2015, and assigned Florida Document Number L15000080092.
