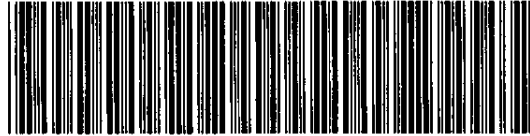

The name of the Limited Liability Company is SAN MIGUEL ASSOCIATES, LLC.


