The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **JSR FLOWRIGHT LLC** ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 242 Coconut Drive, Indialantic, Florida 32903 and the mailing address shall be the same.

**ARTICLE 3 - EFFECTIVE DATE**




