**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605, Florida Statutes, the undersigned being authorized to execute and file these Articles, adopts the following *Limited Liability Company* Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is the Ka-Ja Transportation, LLC.

ARTICLE II - MAILING ADDRESS AND STREET ADDRESS

ARTICLE III - DURATION

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

ARTICLE IV - PURPOSE


ACCEPTANCE OF APPOINTMENT OF REGISTERED AGENT
