**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

First: The Articles of Organization of Virginia View LLC were filed with the Florida Secretary of State on May 8, 2015 and assigned Document Number L15000081920.

Second: Such Articles of Organization (the "Articles") are hereby deleted in their entirety and Amended and Restated as follows:

ARTICLE I. NAME


