Initial Board of Managers**

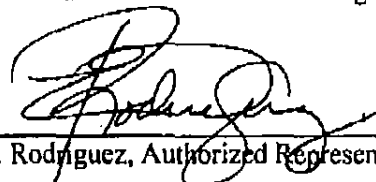
