The undersigned, Alex J. Jeffrey, a natural person competent to contract and a member of Jeffrey Dental, LLC, a Florida limited liability company (the "Company"), hereby presents these Amended and Restated Articles of Organization pursuant to the provisions of Section 605.0202, *Florida Statutes*. These Amended and Restated Articles of Organization have been duly adopted by the members of the Company.

FIRST: The Company's Articles of Organization were filed on May 11, 2015, with the Florida Department of State and assigned document number L15000082960.

SECOND: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

THIRD: The Company's Amended and Restated Articles of Organization are set forth in their entirety as follows:

**ARTICLE I - NAME**

The name of this professional limited liability company shall be:
