The undersigned subscriber to these Articles of Organization, a natural person Empetent to contract, does hereby form a limited liability company under the laws of the State of Florida.

# ARTICLE I

The name of the limited liability company shall be Fort Brooke Advisors, LLC.

## ARTICLE II Address and Place of Business
