ARTICLES OF ORGANIZATION OF CHERISHOME ALTAMONTE LLC

ARTICLE I Name

The name of this limited liability company is CHERISHOME ALTAMONTE

ARTICLE 11 Existence

This limited liability company shall have perpetual existence.

ARTICLE III Purpose
