**ARTICLES OF ORGANIZATION

**ARTICLE I  
Name**

The name of this limited liability company is **CHERISHOME ALTAMONTE LLC**

**ARTICLE II  
Existence**

This limited liability company shall have perpetual existence.

**ARTICLE III  
Purpose**
