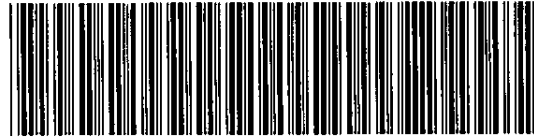

*The Limited Liability Company shall be managed by at least one Manager and is, therefore, a Manager-managed company. The name and address of the Manager are as follows:*




