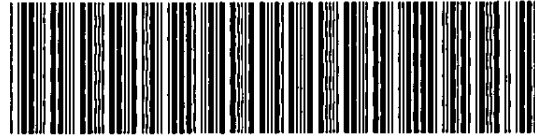

Articles of Organization of NationalHemp, LLC, a Florida limited liability company.

The undersigned person, acting as authorized representative of this not for profit entity under the Florida Limited Liability Company Act, as set forth in Chapter 605 of the Florida Statutes, adopts the following Articles of Organization for such limited liability company:

ARTICLE I
Name and Address

The name of the entity is NationalHemp, LLC. The street address of the limited liability company's principal place of business is:

ARTICLE II
Duration

The duration of the company is perpetual.

ARTICLE III
Purpose and Powers

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature and purpose of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

- a) To advocate for sensible Cannabis laws which help to advance industrial hemp access, public awareness, research, and market expansion through education, legislation, communication and NationalHemp.org member's services and benefits;
- b) To advance legislation that ends the prohibition against hemp cultivation;

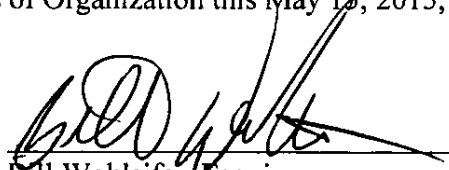
