ARTICLE V**MANAGEMENT; INITIAL MEMBER**

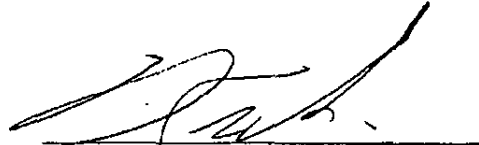
