#### PLAN OF CONVERSION

WHEREAS PARADIGM BREWING COMPANY, LLC, a Washington limited liability company ("WA LLC"), wishes to convert into a Florida limited liability company, subject to approval by the Members of the Company, and the filing of the Articles of Conversion and Articles of Organization with the Florida Secretary of State; and

WHEREAS, the Florida Revised Limited Liability Company Act requires WA LLC to adopt a Plan of Conversion:

NOW, THEREFORE, WA LLC hereby sets forth the details for such conversion.

- 1. <u>Plan of Conversion</u>. WA LLC hereby adopts this Plan of Conversion ("<u>Plan</u>") to convert WA LLC to a Florida limited liability company to be known as PARADIGM BREWING COMPANY, LLC (the "<u>Company</u>"), and authorizes Ty Eriks to perform such acts and execute such documents as may be necessary or convenient to effect the Plan, including but not limited to, the execution of the Articles of Conversion, Articles of Organization and Operating Agreement of the Company (on behalf of the Company).
- 2. <u>Effect of Conversion</u>. Upon the filing of the Articles of Conversion and Articles of Organization with the Florida Secretary of State (the "<u>Effective Date</u>"), (a) WA LLC shall be converted into a Florida limited liability company pursuant to Section 605.1045 of the Florida Revised Limited Liability Act; (b) each percentage of the issued and outstanding Membership Interests of WA LLC shall be converted into one equivalent Membership Interest of the Company; and (c) all of the assets and liabilities of WA LLC shall be transferred and assigned to the Company. Following such assignment and transfer, WA LLC shall be terminated. Any Member of WA LLC is hereby authorized to file appropriate termination and/or dissolution documents for WA LLC with the State of Washington.
- 3. <u>Taxpayer Identification Number</u>. Notwithstanding the foregoing, WA LLC shall not be terminated for tax purposes but rather a new IRS Form SS-4 will be filed to transfer the taxpayer identification number of WA LLC to the Company.
- 4. <u>Business of Company</u>. The business of WA LLC shall continue to, and be carried on by, the Company after the Effective Date in accordance with the provisions of the Florida Revised Limited Liability Company Act, the Articles of Organization, and the Operating Agreement of the Company.
